*THE RIDGEFIELD ANTIQUES MARKET IS HELD ON THE FRONT LAWN OF THE LOUNSBURY HOUSE AND COMMUNITY CENTER, ON THE MAIN STREET OF THIS CHARMING TOWN, less than a block from the fine shopping district and surrounded by stately Victorian homes. Ample parking is located behind two churches across the street for customers and for those dealers who will be moving their vehicles. The lawn of the Lounsbury House can accommodate approximately 100 dealers. This is an antiques/collectibles show.*

**NEW MERCHANDISE AND/OR REPROS ARE NOT PERMITTED.**

**Single LAWN booths** - 20' x 20 are \$200. One vehicle no longer than 20' may remain in space. Longer vehicles will require double booths. Booths-and-a-half are not available. Vehicles taller than a van may need to be parked across the street or in a yet-to-be-determined designated area.

**Single TENT booths** - 10' x 15' are \$350. Reserved corner tent booths are an additional \$40. Tent dealers may unload at their booths. Booths-and-a-half are not available.

**Tables** - 8' tables are available for \$15 each. All tables must be rented seven days in advance.

**BOOTH RENT INCREASES BY \$35 TWO WEEKS PRIOR TO SHOW DATE.**

**A \$100 NON REFUNDABLE DEPOSIT MUST BE SENT WITH THIS APPLICATION.** THE BALANCE IS DUE ONE MONTH PRIOR TO SHOW DATE AND NO REMINDERS WILL BE SENT. WE ENCOURAGE YOU TO INCLUDE A POSTDATED CHECK OR WE CAN AUTOMATICALLY CHARGE YOUR ACCOUNT FOR THE BALANCE FOR A 5% ADMINISTRATIVE FEE. If balances are not received on time, Cord Shows reserves the right to resell the space. There is a \$25 fee for checks returned by the bank. If cancellation is received in writing no less than two weeks prior to show date, Cord Shows will retain a \$100 service fee. The balance will be applied to a mutually agreed upon show within one year.

**SET-UP:** Cord Shows expects to be able to allow dealers to set up starting at 1 PM Friday with a halt from 3:00 - 3:30 while children are being picked up from school. A line will form on Market Street. Please look for further details to follow. Saturday set-up begins at dawn. Come directly to the show property's Market Street entrance. The only spaces that will be reserved are those under the tent. If you wish to be next to someone, please arrive in line together.

**YOU MAY SLEEP IN YOUR VEHICLE. WE WILL HAVE SECURITY.**

**Please note** that "limited time parking" is NOT enforced on weekends thus parking is available on most streets around the show as well as in various adjacent parking lots. This will be part of the show's promotion.

- This show is being held rain or shine so please come prepared.
- Do not bring dogs. Unlike at our other outdoor venues, we are not forbidding the public from bringing dogs because there is so much foot traffic in the area that to do so might cut down on attendance significantly.
- Complimentary coffee/tea, and rolls will be available during set up Saturday only.
- The show will be catered.
- You will be given a garbage bag. Please clean up your area and drop your garbage in the dumpster near the big tent.
- We will offer credit card service for sales over \$50 (on the veranda) for a 5% service charge to be covered by the dealer and not the customer. Just go to one of the admission tables to have Vivien called on the walkie-talkie.

Tents/canopies MUST be staked down. Guidelines must be safely visible.

Merchandise must be antique or vintage collectible.

NO REPRODUCTIONS, NEW MERCHANDISE OR CRAFTS ARE PERMITTED. IF YOU CAN'T GUARANTEE AN ITEM, DO NOT PUT IT OUT AS MERCHANDISE MUST BE GUARANTEED AS TO AGE, CONDITION & AUTHENTICITY.
