READ THIS CAREFULLY PLEASE:

THIS SHOW IS FUN! IF YOU CAN'T FOLLOW THE SIZE LIMITATIONS PLEASE DO NOT PARTICIPATE. REMEMBER THAT YOU CAN DO A "REGULAR" ANTIQUES SHOW ANY WEEKEND. THE CHALLENGE OF THE SIZE LIMITATION IS WHAT SETS THIS SHOW APART. HERE IS WHAT TO BRING: ANTIQUE AND ESTATE JEWELRY, ANTIQUE AND ESTATE SILVER (ANY SIZE), PLUS GENERAL ANTIQUES AND COLLECTIBLES WHICH MEASURE NO LARGER THAN 6" TALL BY 6" WIDE.

PLUS: IF YOU CAN FOLD IT SO THAT IT IS DISPLAYED NO LARGER THAN 6" X 6" YOU MAY BRING IT. THIS COULD INCLUDE NAPKINS, DOILIES, VINTAGE NECKTIES AND BELTS BUT NOT TABLE CLOTHS! WHEN DISPLAYED, ITEMS MUST BE FOLDED UNLESS BEING LOOKED AT.

DECORATIVE LAMPS MAY BE USED BUT THEY MAY NOT BE SOLD AT THE SHOW UNDER ANY CIRCUMSTANCES. YOU MAY NOT DISPLAY CHRISTMAS ORNAMENTS ON TREES; YOU MAY NOT SELL SHOWCASES OR DISPLAY ITEMS. WE OFFER YOU NUMEROUS SHOWS AT WHICH TO SELL THESE ITEMS. PLEASE KEEP THE FUN IN THIS SHOW.

BOOTHS SIZE AND RENT: SPACE IS RENTED BY THE RUNNING FOOT. Only the rented table space can be used to sell from. The fee is **\$14 per foot plus \$10 per table. (6' or 8' length) with a minimum booth size of 8'. One worktable may be rented or brought by the exhibitor; however, **these may not be used to sell from.****

ELECTRICITY AND CHAIRS ARE INCLUDED. DEALERS WILL BE CHARGED FOR ANY "CHEATING" at \$14 per running foot and made to correct the situation! It is the dealer's responsibility to check their merchandise and comply or risk never being permitted to do this show again. Management WILL spot check and no exceptions will be made.

Remember you can build up from the tables so be creative! Tables are placed end to end in rows. Dealers sit behind their displays. In the center aisles booths are back to back with about 7 feet between the backs of booths. There is enough space between booths for exhibitors to pass through. Some booths may form a corner.

PAYMENT: A \$100 NONREFUNDABLE DEPOSIT MUST BE RECEIVED WITH THIS APPLICATION. **BOOTHS MEASURING 1 (8') TABLE FOR \$122 MUST BE PAID IN FULL WITH THE RETURN OF THIS APPLICATION.**

YOU MAY INCLUDE A POSTDATED CHECK FOR YOUR BALANCE DATED NOV. 19, 2010. IF YOU WOULD RATHER NOT INCLUDE A POSTDATED CHECK PLEASE BE ADVISED FULL PAYMENT IS DUE BY THIS DATE. REMINDERS WILL NOT BE SENT. YOU MAY ELECT TO HAVE CORD SHOWS AUTOMATICALLY CHARGE YOUR ACCOUNT FOR YOUR BALANCE ON THE DUE DATE FOR A 5% ADMINISTRATIVE FEE. There is a \$25 service charge for any checks returned by the bank.

SETUP: Dealers may arrive at 7 AM Sunday. Porter help is NOT available; however, there are plenty of large dollies for your use. ALL EXHIBITORS MUST BE MOVED IN BY 9 AM SO DOORS CAN BE SECURED. ALL TABLES MUST BE COVERED ON ALL FOUR SIDES TO THE FLOOR. IF POSSIBLE COVER IN MATCHING FABRIC. WORK TABLES MUST ALSO BE COVERED. LIGHTS ARE SUGGESTED FOR YOUR DISPLAY AND YOU WILL HAVE ONE OUTLET IN YOUR BOOTH. TABLE COVERS MUST BE FIRE RETARDANT. (If possible bring written proof).

REFRESHMENTS WILL BE COMPLIMENTARY DURING SET UP AND LOAD OUT. THE SHOW IS CATERED BY LUPINACCI'S DELI.

CORD SHOWS LTD. WILL PROCESS CREDIT CARD SALES FOR A 5% ADMINISTRATIVE FEE.

DIRECTIONS: From I-95 exit 5 turn right and make your first right. Follow our yellow signs.

THE FOLLOWING RULES MUST BE FOLLOWED BY ALL EXHIBITORS:

- 1) Booths are not to be shared.
- 2) All names of persons who will be in the booth must appear on this contract.
- 3) No more than 2 people can tend a single table or 3 in larger booths.
- 4) All booths must be completed one-half hour before show time.
- 5) Exhibitors must arrive no later than 8 AM and be moved in by 9.
- 6) No exhibitor is permitted to pack early under any circumstances.
- 7) All merchandise must be price tagged.
- 8) All booths must be kept safe and presentable and left spotless.
- 9) Dealers must hold a valid CT resale number. If you need a number see below.
- 10) **No new merchandise, or reproductions. This is an ANTIQUES SHOW.**
- 11) Dealers **must** guarantee the age, condition & authenticity of their merchandise.
- 12) Exhibitor **must** use appropriate and descriptive sales receipts including contact info.

IF DOWNLOADING, PLEASE KEEP A COPY FOR YOUR RECORDS AND SEND THE FOLLOWING CONTRACTUAL PORTION OF THE APPLICATION WITH PAYMENT. IF RETURNING AN ORIGINAL, CORD SHOWS WILL SEND YOU A COPY. A SELF-ADDRESSED STAMPED BUSINESS-SIZE ENVELOPE WOULD BE APPRECIATED.
