You are invited to join one of the longest running holiday show traditions in the Northeast. There are no other shows like it. *The Antique Holiday Stocking Stuffers Show* is popular so be sure to return your application early. Approximately 70 dealers can be accommodated. At the new location in the beautiful John Jay High School, we will utilize the wide, bright hallways and the cafeteria. Access is easy through several doors and there is extensive parking. PORTERS WILL BE AVAILABLE and we will have security. This show is a benefit for the JJHS PTO.

John Jay High School is located at 60 North Salem Rd., (Rte. 121N) which is just off Route 35. From exit 6 off Route 684 go East for 4 miles and left onto N. Salem Road.

READ THIS CAREFULLY PLEASE:

THIS SHOW IS FUN! IF YOU CAN'T FOLLOW THE GUIDELINES PLEASE DO NOT PARTICIPATE. REMEMBER THAT YOU CAN DO A "REGULAR" ANTIQUES SHOW ANY WEEKEND. THE CHALLENGE OF THE SIZE LIMITATION IS WHAT SETS THIS SHOW APART.

HERE IS WHAT TO BRING: ANTIQUE, ESTATE, VINTAGE COSTUME, ETHNIC JEWELRY; ANTIQUE AND ESTATE SILVER (CAN BE ANY SIZE), to include silver plate, silver overlay, sterling, coin, etc. You may sell a silver chest with contents of flatware. GENERAL ANTIQUES AND COLLECTIBLES WHICH MEASURE NO LARGER THAN 6" TALL BY 6" WIDE are allowed. PLUS, IF YOU CAN FOLD IT SO THAT IT IS DISPLAYED NO LARGER THAN 6" X 6" YOU MAY BRING IT. THIS COULD INCLUDE NAPKINS, DOILIES, VINTAGE NECKTIES AND BELTS BUT NOT TABLE CLOTHS! WHEN DISPLAYED, ITEMS MUST BE FOLDED UNLESS BEING LOOKED AT.

DECORATIVE LAMPS MAY BE USED BUT THEY MAY NOT BE SOLD AT THE SHOW UNDER ANY CIRCUMSTANCES. YOU MAY NOT DISPLAY CHRISTMAS ORNAMENTS ON TREES. YOU MAY NOT SELL SHOWCASES OR DISPLAY ITEMS. Please abide by our rules, as this is why the show is so popular.

BOOTHS SIZE AND RENT: SPACE IS RENTED BY THE RUNNING FOOT. All tables are placed end to end and all tables must be rented so they are in place when you arrive. **Only the rented table space may be used to sell from. You should be creative and build your display upon your table(s). Dealers sit behind their displays.** There is no selling from showcases placed on the floor, merchandise stored under tables, from windowsills or from chairs. Showcases may not straddle separated tables. There will be at least two feet between booths.

BOOTH RENT: \$14 per foot plus \$15 per table. (6' or 8' length) with a **minimum booth size of 8'**. One worktable may be rented for \$10 or brought by the exhibitor; however, **these may not be used to sell from.** ELECTRICITY AND CHAIRS ARE INCLUDED. DEALERS WILL BE CHARGED FOR ANY "CHEATING" at \$14 per running foot and made to correct the situation! It is the dealer's responsibility to check their merchandise and comply or risk never being permitted to do this show again. Management WILL spot check and no exceptions will be made.

PAYMENT: A \$100 NONREFUNDABLE DEPOSIT MUST BE RECEIVED WITH THIS APPLICATION. **BOOTHS MEASURING 1 (8') TABLE FOR \$127 MUST BE PAID IN FULL WITH THE RETURN OF THIS APPLICATION.** PLEASE INCLUDE A POSTDATED CHECK FOR NOVEMBER 18TH OR A CREDIT CARD NUMBER FOR YOUR BALANCE TO BE CHARGED NOVEMBER 18TH. THERE IS A 5% FEE FOR CHARGES. There is a \$25 service charge for any checks returned by the bank.

SETUP: Dealers may arrive at 7 AM Sunday. ALL EXHIBITORS MUST BE MOVED IN BY 9 AM SO DOORS CAN BE SECURED. ALL TABLES MUST BE COVERED ON ALL FOUR SIDES TO THE FLOOR. IF POSSIBLE, COVER IN MATCHING FABRIC. OVERHEAD LIGHTS MAY BE SUFFICIENT BUT AN OUTLET WILL BE IN CLOSE PROXIMITY. PLEASE BRING AN EXTENSION CORD.

REFRESHMENTS WILL BE COMPLIMENTARY DURING SET UP AND LOAD OUT IN THE CONFERENCE ROOM BEHIND THE MAIN ENTRANCE. FOOD WILL BE AVAILABLE IN THE CAFETERIA.

We regret that Cord Shows Ltd CANNOT process credit cards from this location.

THE FOLLOWING RULES MUST BE FOLLOWED BY ALL EXHIBITORS:

- 1) Booths are not to be shared.
- 2) All names of persons who will be in the booth must appear on this contract.
- 3) No more than 2 people can tend a single table or 3 in larger booths.
- 4) All booths must be completed one-half hour before show time.
- 5) Exhibitors must arrive no later than 8 AM and be moved in by 9.
- 6) No exhibitor is permitted to pack early under any circumstances.
- 7) All merchandise must be price tagged.
- 8) All booths must be kept safe and presentable and left spotless.
- 9) Dealers must hold a valid NY resale number. If you need a number see below.
- 10) **No new merchandise, or reproductions. This is an ANTIQUES SHOW.**
- 11) Dealers **must** guarantee the age, condition & authenticity of their merchandise.
- 12) Exhibitor **must** use appropriate and descriptive sales receipts including contact info.

SNOW INSURANCE: For 10% of your booth rent you will get a full refund if we receive 3" or more of newly fallen snow from 2:00PM on Dec. 15th to 2:00 PM on Dec. 16th. **DEALERS RENTING BOOTHS IN EXCESS OF \$300 WILL BE CHARGE 5% OF THEIR BOOTH RENT FOR SNOW INSURANCE. This must be paid in full no less than 2 weeks prior to show date. DEALERS MUST MAKE EVERY EFFORT TO ATTEND THE SHOW IF NOT CANCELLED WITHOUT PUTTING THEMSELVES IN HARMS WAY.**
